# What Are Unions Asking For?

- IAFF Stock Proposal:
  - If an employee is suspected of being under the influence, they get sent to a doctor.
  - Doctor performs a blood test screening for cannabis.
  - A positive test is defined as \_\_\_\_ ng/ ml of THC.
  - Doctor examines all alternate medical explanations, employee's medical history, other relevant biomedical factors.
  - Doctor opines on whether the individual was high at work.
  - No action can be taken without a finding that the employee was impaired by the doctor.
  - If there's a negative finding, then test results/communications are destroyed.

# Other Legislative Changes:

HB 0351 (Expansion of Secondary Employment)

- Amends the Firefighter Pension Code:
  - Requires the fire chief of a secondary employer to report any injury, illness, or exposure incurred by a secondary employee during his or her employment to the Department of <u>Insurance</u>.
  - Requires secondary employers to transmit to the Department of <u>Insurance</u> a certified copy of its report accounting for all hours worked by secondary employees.
- Public Act 102-0059, effective July 9, 2021.

## Other Legislative Changes: SB2150 (Original Appointment Qualifications)

- Amends Both Illinois Municipal Code 65 ILCS 5/10-1-7.1 and Fire Protection District Act 70 ILCS 705/16.06b
- Firefighter qualifications/Pre-requisites to appointment:
  - The age limit of 35 shall not apply to: ... "(2) any person who has served a [*municipality* or Fire Districts (depends on which code)] as a regularly enrolled volunteer, paid-on-call, or part-time firefighter for the 5 years immediately preceding the time that the municipality begins to use full-time firefighters to provide all or part of its fire protection service,"
- Impacts to Part-Time.
- As of 8/10/2021 Has not (yet) been signed by Governor.

Other Changes:

# HB 3763 (Fire Protection Dist. Response Times)

- Amends the Fire Protection District Act.
- before closing a fire station or dissolving the district (even annexation to municipality or consolidation) a response-time study must be conducted
  - Must show estimated response times to the territory currently served by the fire station or district <u>and</u> estimated response times to that territory after closure of the fire station or district (or annexation/consolidation).
- As of 8/10/2021 has yet to be signed by Governor.

## Other Legislative Changes: SB 2486 (Personnel Record Review Act)

- Amends the Personnel Record Review Act.
- Provides that an individual aggrieved by a disclosure of a disciplinary report in violation of the Act may file a complaint with the Director of Labor or file an action in court within 7 years after the violation.
- As of 8/10/2021 Has not yet been signed by Governor

## Bill Update – HB0220 (Battalion Chiefs)

- Passed House (93-13), died in Senate upon arrival.
- Would have put Battalion Chiefs in Union.
- (Amends the Illinois Public Labor Relations Act. Modifies the definition of "supervisor" under the Act. Provides that in fire fighter units employees shall consist of fire fighters of the highest rank of company officer and below (currently, highest rank not specified). Provides that a company officer may be responsible for multiple companies or apparatus on a shift, multiple stations, or an entire shift. Provides that there may be more than one company officer per shift.)
- Provides that all other ranks above that of the highest company officer shall be supervisors (currently, highest rank not specified).

# COVID Update – Open Meetings Act

- Unclear State of Emergency
  - Governor's State of Emergency Language vs. text of OMA 7(e)
  - Situation may be changing with rise of Delta cases (and Lambda on the horizon)
